RESOLUTION NO. 3736, S-2026

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMELITA A. ABALOS, TO DONATE THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) IN FAVOR OF THE MUNICIPAL GOVERNMENT OF MAGDIWANG, ROMBLON TO BE UTILIZED IN THEIR RECOVERY RESPONSE EFFORTS TO THE DEVASTATION CAUSED BY SEVERE TROPICAL STORM "OPONG"

WHEREAS, the City of Mandaluyong maintains a strong bond of "Sister City" relations with the Municipality of Magdiwang, Romblon, rooted in mutual support and shared humanitarian values;

WHEREAS, the Municipality of Magdiwang, through Municipal Resolution No. 25-184, has formally requested assistance following the severe impact of Tropical Storm "Opong", which caused significant damage to homes, public utilities, and agricultural livelihoods;

WHEREAS, pursuant to Section 324 (d) of Republic Act No. 7160 (Local Government Code of 1991), local government units may provide financial assistance to other LGUs in areas declared under a state of calamity or those suffering from unforeseen disasters;


WHEREAS, the City Government of Mandaluyong recognizes the need for humanitarian intervention to aid in the rehabilitation and relief efforts for the affected families in Magdiwang.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable Carmelita A. Abalos to donate the amount of ONE HUNDRED THOUSAND PESOS (PHP 100,000.00) as financial assistance to the Municipality of Magdiwang, Romblon to be utilized in their recovery response efforts to the devastation caused by severe tropical storm "Opong".

RESOLVED, FURTHER, that copy of this Resolution be forwarded to the Office of the City Mayor, the City Treasurer, and the Municipal Government of Magdiwang, Romblon, for their information and appropriate action with full authority to sign and execute appropriate documents with the authorized representative of such Local Government Unit, under such terms and conditions she may deem necessary under the premises.




